

At a court of Pleas and Quarter Sessions began and held for the County of New Hanover at the Court House in Wilmington on Monday, the 6th day of October. A.D., 1806 and in the 31st year of independence.

The court opened with the usual proclamations.Present the Worshipful: William Giles, H. Kelly, John M. Gabie.

A deed from Sion <u>Picket</u> to James <u>Evans</u> proved by John <u>Chadwick</u> and ordered to be registered.

Court adjourned till 10 o'clock tomorrow.

Tuesday, 7th October 1806.

Court met according to adjournment. Present the Worshipful: Anthony <u>Bordeaux</u>, David **Jones**, Jr., William **Jones** and David **Jones**.

Samuel <u>Buxton</u>, Josiah <u>Register</u>, Bartholomew <u>Byrn</u> appointed to divide the personal estate of Stephen <u>Williamson</u> between the widow and heirs.

A deed from A.D. <u>Bordeaux</u> to James <u>Malpas</u> acknowledged in open court and

ordered to be registered.

A deed from Wm. W. Jones to Hinton James proved by E.J. Osborne and ordered to be registered.

Court met according to adjournment. Present the Worshipful: Samuel <u>Ashe</u>, Jere <u>Nichols</u>, Thomas <u>Bishop</u>.

Ordered that the Sheriff do hire out two Negroes, Tunder and JoSh, now in the custody of the jailor, from year to year until the owners come forward, and pay the amount of their fees out of such hire to the jailor, the said Tuner's fees being \$35.75 and Josh's fees ____ and the balance of their annual hire be paid into the clerk's office.

Upon the petition of John $\underline{McAuslan}$, \underline{Exor} , of George $\underline{Merrick}$, ordered that a Negro man slave named \underline{Jack} , the property of the said George, be emancipated and set free from slavery.

Ordered that the Sheriff summon a jury of freeholders to lay off a public road from the river to the Sea Beach at Federal Point at the place where is has been usual for the New Inlet Pilots to haul their boats across, in the manner and agreeably to the rules and regulations prescribed by the Act of Assembly in such care made and provided.

A deed from Junius C. $\underline{\text{Dunbibin}}$ to Wm. $\underline{\text{Wilkerson}}$ acknowledged in open court and ordered to be registered.

A deed from David $\underline{\text{Williams}}$ to Hy $\underline{\text{Williams}}$ proven by Neal $\underline{\underline{\text{Wall}}}$ and ordered to be registered.

Ordered that the Sheriff have the stocks with a pillary erected upon the place which Hanson Kelly and Sam'l <u>Bludworth</u> shall point out, to be paid for by the county.

Dear ONHGS Publications Committee,

For the past three years I have been working with Dallas Herring and Horace Fussell to resume publication of the Minutes of Duplin County's Court of Pleas and Quarter Sessions. We began where Mrs. McEachern's series ended. I am happy to say that two volumes have been completed (Part 8: 1809-1811 and Part 9: 1812-1813). A third volume (Part 10: 1814-1816) will probably be available before the end of 1994. The series will continue until one or another of us wears out.

I do not know if your Committee has been informed of our projects and am taking this opportunity to do so. In addition to the Court Minutes, I am working on the transcription and indexing of the 1860 and 1870 Federal Census records of Duplin County, also under the auspices of the Duplin County Historical Society. I realize that you published the 1830 and 1840 censuses for the county, and I want to prevent duplication with respect to 1860 and 1870. It is also my intention to transcribe and index the 1880 census.

I always look forward to your new publications list. The work that you do is an inspiration to all lovers of genealogy and history, and I am proud to be a member of the ONHGS organization.

FENNELL - MOORE BIBLE RECORDS

[The following bible records were submitted by Susan Usher Eggert, 805 Usher 28470. Mrs. Eggert writes " given the widespread Ave., Shallotte, NC connections of the Fennell and related families, I thought the Courier might be interested in data from a family Bible handed down by Miss Margaret Fennell Moore (1865-1947), now in the possession of my first cousin, Miss Tammy Southerland, P.O. Box 434, Moultrie, GA. Aunt Maggie's family Bible, which we believe she inherited from her mother, Mary Bryan Devane, went at her death to her half-sister, Mrs. Charles Augustus (Josephine Thames) Usher, my paternal grandmother, with whom she made her home for many years in both Columbus and Brunswick counties, and perhaps Cumberland as well. I also have family pages only (no frontispiece) from a family Bible Capt. J.F. Moore, Maggie's father, received when he was at Charleston, S.C., during the Civil War, which has passed down to my grandmother Josephine, and now is in the possession of my sister, Carol Usher Hardee. Maggie Moore's Bible-- which we call the Fennell or the Fennell/Devane Bible, has a frontispiece that reads (abbreviated) Holy Bible containing the old and new testaments together with the Apocrypha ...published and sold by Daniel D. Smith, New York, 1828. The asterisks (*) indicate the line that eventually connected Miss Moore to my family by marriage. The data was recorded in three different person's writing over the years." Mrs. Eggert will be glad to exchange information on the Usher and Thames families. She is also some what interested in the Fennell, Devane and Bryan lines, but has no information on the Moore or Jones families.]

ROBERT HOGG ACCOUNT BOOKS

Robert Hogg, born before 1728 and died 1780, was settled in Wilmington, North Carolina by 1756. He was from East **Lothian** in northern Scotland and the son of Gavin and Helen Stevenson Hogg. His two brothers, James and John also emigrated to the Cape Fear area.

Hogg formed a business partnership with Samuel Campbell, and together they established a large and important mercantile firm. Their Wilmington business operated branches in Cross Creek(later Fayetteville). Hillsborough, Swansboro, New River, and Bladen County. The firm also carried on trade with merchants in Great Britain, the West Indies, and the other continental colonies. They exported naval stores, deerskins, and flour, and sold various manufactured goods, ie., sugar, coffee, tea, rum, and sometimes slaves to their local customers. At the time the company was dissolved in 1778, annual profits approximated 1,200 pounds sterling, and the gross assets for the firm were 18,330 pounds sterling. Because an established merchant was expected to earn more than 500 pounds sterling per annum in the Revolutionary Era, the firm was obviously prospering.

The original Hogg & Campbell account books are in the Southern Historical Society collection at the University of North Carolina at Chapel Hill. The following "Balance of the Books of Hogg & Campbell" was submitted by John Gerdes and transcribed by Bill Reaves. The firm was far reaching enough to do business with almost every landowner in the area, providing us with a detailed list of Revolutionary Era residents.

Robert Hogg never married. On a visit to Scotland in 1772, he urged his brother James to emigrate, and in 1774 James Hogg arrived with his family. James worked for his brother by managing first the Cross Creek store and later the outlet at Hillsborough. Robert Hogg died before 7 July 1780, when he was supposed to have sat on a grand jury. He left his estate to brother James.

Extraordinary Longevity

[The September 1994 Courier published the Revolutionary War service of William Pridgeon, a favorite patriot of the Cape Fear area. Helen Moore Sammons has submitted his obituary which was published in the Wilmington Chronicle, 24 December, 18451.

"Died in Bladen County, N.C. on the 14th Oct. last, Mr. Wm. Pridgen, aged 123 years!! He entered is 124th year in June last. He volunteered to serve his country in the Continental Army of the Revolution, and, thought then exempt by reason of being over age, he served a full term in that war, and has received a Pension for many years past. He has lived to follow all his children to the grave, except one, an aged daughter. His grandchildren are aged people, and he has left great grandchildren upwards of 40 years of age, and great great grandchildren about 12 years of age. He retained his faculties till his death, except his sight, which he lost a few years ago. He was able to walk until a few days before his death, when attacked by fever, of which he died."

The Marriage of James Innes Continued...

It was reported in the September 1994 Courier that James Innes, militia captain and educator, of Wilmington, was married to Jean Miller on 25 June 1690 in Caithness, Thurso, Scotland. Dr. John Scalf of Wilmington writes that this cannot be the Jean than married Capt. Innes because his wife did not die until 1775 (her will is in the North Carolina Secretary of State papers, box 843). After James Innes died in 1759 (New Hanover County Deed Book D, page 402) his wife Jean married Francis Corbin in 1761. Their prenupual agreement can be found in New Hanover County Deed Book E, page 88-94. Perhaps, in the future, we will find the illusive surname of Jean who was wife to the James Innes of Wilmington.

Also, we sponsor a fellowship tent at several Scottish Games over the country. Many folk join KFA, \$14.00/year, to get our award-winning bulletin, The Boarder Line, which typically carries some inquiries for readers kinsearching." He is presently trying to tie together the Daniel Kerr family of Black River with the Joseph T. Kerr family of Wilmington. He personally has several lines in the New Hanover/Sampson area.

The Genealogy Section of the North Carolina State Library has received as a gift of the United Daughters of the Confederacy the Consolidated Index to Compiled Service Records of Confederate Soldiers. These 535 rolls of microfilm reproduce an alphabetical card index containing all the names of Confederate soldiers found in the records used in compiling the service records, regardless of whether the service was with unit furnished by a particular state, with a unit raised directly by the Confederate government, or as a staff officer. The North Carolina Archives has also received from the UDC a similar record of Confederate Naval Service Records. The value of these extensive records in researching service records cannot be overstated. [From Updates, Wake County Genealogical Society, Raleigh, NC, Spring 1994].
