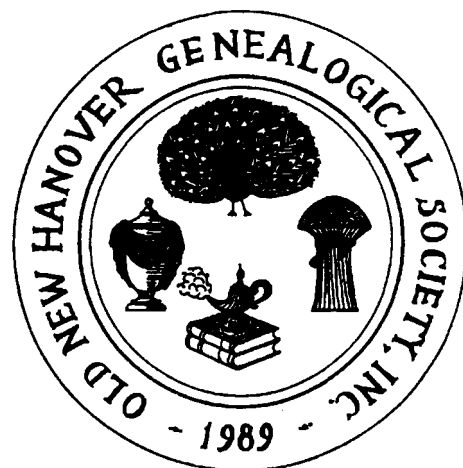

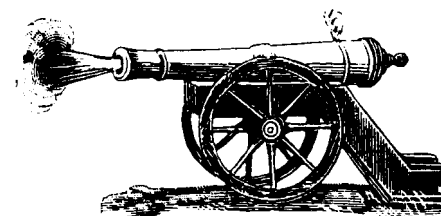
Clarendon Courier: Members receive this quarterly in the Spring, Summer, Fall, and Winter. The deadline for submission of material

[This series (which began in the Fall 1996 Courier) lists soldiers who were wounded, captured, or lulled at the Battle of Fort Fisher. The wounded and captured were sent to Elmira Prison in New York or Point Lookout Prison in Maryland. The following abbreviations are used: Reg. for Regiment, Bat. for Battalion. N.C.T. for North Carolina Troops, N.C.S.T. for North Carolina State Troops, N.C.H. Art. for North Carolina Heavy Artillery, N.C.L. Art. for North Carolina Light Artillery, and * indicates that the soldier was killed in action. The 10th Regiment included the 1st NC Artillery, the 36th Regiment included the 2nd NC Artillery, and the 40th Regiment included the 3rd NC Artillery.]

Carolina Tri-Weekly Commercial

Tues 7 Aug 1855- Died: At Wrightsville Sound on the 5th of August, 1855, Melvina C., infant daughter of R.H. and Melvina GRANT, aged 14 months.

Tues 4 Nov 1856- Died: On the 1st of November and in the 54th year of her age, Mrs. Caroline A. GREEN, wife of Mr. James S. GREEN, of this place.

Thur 31 July 1851- Died: In Natchez on the 4th inst. and in the 23d year of her age, Miss Mary W., eldest daughter of the Rt. Rev. William M. GREEN, D.D., Bishop of the Diocese of Mississippi.

Tues 9 Feb 1858- Married: In Sampson county on the 4th inst. by Rev. E.L. Perkins, Mr. Wright GREGORY and Miss Ann Eliza, daughter of Lewis McCALEB, Esq.

Sat 8 Mar 1856- Died: At the residence of Franklin J. Faison, Esq., in Sampson county on the 9th ult., Mr. John W. GRICE, aged 52 years.

Sat 26 Apr 1856- Married: In Fayetteville on the 24th inst., by Rev. James H. Brent, Mr. Henry W. GROVES, of Wilmington, to Miss Sarah A. SUNDY, daughter of Capt. James SUNDY, of Fayetteville.

Tues 5 Sept 1854- Died: At Wappoo Mills near Charleston, S. C. on the 1st inst., Mrs. Julia A. GROVES, aged 25 years, a native of this place.

Sat 15 Nov 1851- Died: In this town on Wednesday, 12th **inst.**, of typhoid fever, Mr. Samuel D. **HALL**, aged 25 years and 5 months. The funeral will be from the residence of Mr. Wm. A. **Gwyer** on Market St. today at 3 o'clock P. M.

Tues 20 Sept 1853- Died: On the 17th **inst.**, at **Hallettsville**, Long Creek, N. C., Reuben C. **HALLETT**, aged 33 years.

Sat 5 Feb 1853- Notice: On Friday, the **11th inst.**, will be sold at the residence of the late John W. **HAMILTON** his personal property, and land and negroes belonging to his estate will be hired out for one year. Harriet Hamilton and Miles **Costin**, Special admrs.

Sat 25 July 1857- Married: In Duplin county on the 5th

instant, by A. Maxwell, Esq., Mr. J. Obed HANCHEY to Miss Catherine J. BOSTICK, all of said county.

Sat 27 Dec 1851- Married: In Wilmington on the 24th **inst.**, by Rev. R. T. Heflin, M. M. HANKINS and Miss Mary Ann RUGGLES.

Sat 25 July 1857- Married: At Stump Sound in Onslow county on the 12th **inst.** by Joseph Ennett, Esq., Mr. Marke HANSLEY to Miss Harrietta ENNETT, all of said county.

Sat 16 Sept 1854- Died: Recently, at Sneads Ferry in Onslow county, John Giles and Owen HANSLEY got into a scuffle which ended in death for HANSLEY when Giles hit him over the head with a board.

Tues 2 Mar 1852- Married: In this town on the 26th **inst.**, by Rev. Aaron Jones, Mr. William HARVEY to Miss Ann RILEY.

Thur 17 Aug 1854- Died: In this town yesterday, John Edward **HAWKINS**, aged 5 years and 2 months, only child of Edward W. and Henrietta **HAWKINS**.

Thur 11 June 1857- Died: In Raleigh on the 8th **inst.**, William Henry **HAYWOOD** in the 88th year of his age. He was for the last fifty years Clerk of the U.S. Circuit Court for this State.

Thur 9 Feb 1854- Married: In this town on the 2d **inst.**, by James Corbet, Esq., Hr. Charles HEADY to Miss **Eliza** GREEN.

Thur 12 June 1851- Died: At Smithville, N. C. on the 5th **inst.**, Mrs. Jane **HECKMAN**, wife of Capt. Henry **HECKMAN** of Br. Brig Masonic, a native of Nova **Scotia**, aged 23 years.

NEW HANOVER COUNTY DEED BOOK "D"

[Many of New Hanover County's earliest records were destroyed by courthouse fires. What was left of the county's first two deed books, A and B, was combined to form Book AB. This book was abstracted many years ago by Mae Blake Graves. Deed Book C was published in the *Courier* from 1993 to 1996. This series of abstracts of Deed Book D began in the Summer 1997 issue of the *Courier*. New Hanover County was formed in 1729 from Craven County. Bladen and Onslow counties were formed from New Hanover in 1734. Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed to Sampson County in 1795, and Pender County, last but not least, broke away from New Hanover in 1875. The following abstract of Deed Book D, which covers many early records from the above counties, was compiled by Ida Brooks Kellam in 1939 and 1940.]

Page 114. June 20, 1774. John **Davis, Junr.** Sheriff of New Hanover County to Joseph **Jones**, Planter, of same place, said **Jones** obtained judgement against Richard **Ogden**, who lost lot on Dock Street to said **Jones**.

Page 115. August 13, 1754. **Suzana Martindale**, widow, of New Hanover County, late wife of John **Martindale**, decesd. Will published 5 Nov 1752- to Edward **Trafford**, Jos. **Davis** and Jos **Bird**, merchants of Liverpool in Great Britain, a water lot in **Wilmington** on Walnut Street and Front Street. Wit: Samuel **Swann**, Daniel **Dunbibin**, Samuel **Dunbibin**.

Page 116. August 13, 1754. Martin **Merland** of New Hanover County, mariner, to Arthur **Mabson**, merchant of same place, a lot in **Wilmington** on the north side of Market Street joining Dr. Samuel **Green**, one belonging to the Exrs. of the estate of Francis **Veal**, decesd. And joining John **Rutherford's** lot. Wit: **Maraduke Jones**.

Page 117. June 20, 1754. Joseph **Jones** and Martha **Jones**, his wife, of New Hanover County to Alice **Marsden**, widow of New Hanover County, lot on Dock Street joining said Alice **Marsden** and Duncan **Campbell**. Wit: Isaac **Faries**, William **Robinson**.

Page 118. August 8, 1754. Bryant **Lee**, Planter of New Hanover County to William **Gay** of same place, 100 acres on west side of Black

River. Wit: John **Herring**, James **Lewis**, Thomas **Parker, Jr.**

Page 120. Will of Isaac **Black** of **Wilmington**, Parish of St. James, merchant. dated 22 June 1754: Proved Oct 1754. (1) all worldly goods to be equally divided between sister Elizabeth **Woods**, sister Jane **Black** and brother John **Black**. Exr. Joshua **Toomer**. Wit: William **Gregory**, James **Campbell, Jr.**, Mark **Gibbin**.

Page 120. August 28, 1754. John **Lyon**, Merchant of **Wilmington** to John **Merrick** of same place, co-partners in purchasing property - water lot No. 31, front lot No. 32, (both bounded by lot on which Caleb **Grainger's** dwelling house lately stood), lot Nos. 33 and 34. John **Lyon** to have No 32 and John **Merrick** to have Nos 31,33, and 34. Wit: Frederick **Gregg**, John **Davis, Junr.**

Page 122. John **Hensey** of New Hanover County. "now in his Majesty's service as a soldier-' apptd. Joseph **Portivent** and James **Moore**, planters of same place his attys. To collect from the estate of Thomas **Moore**, decesd. "In case there is more money received than needed to clear said estate, the overplus they are required to pay the widow of the deceased. now wife of said John **Hensey**, for use of children of deceased. May 13, 1754. Wit: John **Simpson**, David **James**.



Page 123. Will of Maurice Moore of New Hanover County, Planter, son of Nathaniel Moore of the province and county aforesaid, deceased. Dated 6 December 1753. Proved August 1754.

(1) to wife, Mary Moore, if she remain a widow, plantation whereon I now live and known as Bell Farm, until daughter Mary Moore shall arrive at age of 21 years or the day of her marriage, then the plantation to be equally divided and one part to daughter and other part to wife if she remains a widow, otherwise the whole to my daughter.

(2) to wife for four years my negro man Santee Peter and his wife Elsey, then they to receive a suit of warm clothes and be set free. Also slaves Bristol, Adien, Sam, Walter and London. After my wifes death slave London to go to my son-in-law John **Swann** Porter. Also to wife all household furniture, stocks and cattle, horses, sheep, goats and hogs.

(3) to daughter Mary Moore all other slaves which I own but not herein named. Also 1000 acres called the White Marsh between lands of **Eleazer** Allen, deceased, and Job Howes, which land was willed me by my Uncle Maurice Moore, deceased. Also another tract of 1000 acres on Nesby's Creek about 3 miles from **Wilmington**, unless my brother Nathaniel Moore, who is improving the said land, shall make over to my said daughter Mary his title to a plantation below Brunswick called York Plantation. Then land on Nesby's Creek to go to brother Nathaniel Moore. Said daughter Mary is now a suckling infant. In case she dies before reaching 21 years her legacies to my brothers Schenking Moore, **Berringer** Moore, and Nathaniel Moore. Exectrs: wife, Mary Moore, brother Schenking Moore and Friend Samuel **Ashe**. Wit: **Armand DeRosett**, M.D., Mary **Ashe**, Sarah Porter.

Page 124. April 10, 1754. George Burrington, Esqr. late Governor of North Carolina, but now residing in the Parish of St. Margaret in the County of Middlesex to Samuel **Studwick** of **Mortimer** Street in the Parish of St. Mary Le

Bend, in St. **Anns, Wesminster** in Middlesex, son of Edmund **Studwick** Esqr. deceased, a Plantation called **Stagpark** on the northeast branch of the Cape Fear River containing 10,000 acres. Also a Plantation called Haw Old Fields, lying on the northwest branch of the Cape Fear River containing 30,000 acres, with all the stock of negro residents of said plantations, all cattle, all utensils on said Plantations.

Page 125. April 11, 1754. George Burrington, Esqr., late Governor of North Carolina, now of St. Margarets parish in Middlesex to Jane Studwick, widow, of **Mortimer** Strett in the Parish of St. Mary and Elizabeth Studwick, Spinster, of same place, the only acting executors named in the will of Edmund Studwick, late of Parish of St. **Anns Westminster**, Esqr., deceased and Samuel Studwick, Esqr. son of said Edmund. Whereas King George II, appointed said George Burrington Governor of North Carolina on April 29, 1730, at a salary of 700 lbs. per **annum** to be paid out of revenue of Quit Rents in Carolina, in the hands of John Hammerton, Esqr. Receiver General of Revenues. In 1735, Gabriel Johnston, Esqr. was appointed Governor in place of said George Burrington. Edmund **Studwick** advanced said Burrington several sums of money, 2,280 **lbs.** - so in payment of said debts said Burrington deeded said named lands to said Studwicks.

Page 130. James Lee, Planter of New Hanover County to Richard Malpass, Planter of same place, 300 acres, formerly granted said Lee, Feb. 28, 1754, near Alexander **Colvin's** on May 29, 1754. Wit: John **Simpson**, Samuel Lewis.

News From the Public Library

Bill and the staff at the library have spent the past six months working on the publication of a major local and family history. Entitled *Strength Through Struggle: The Chronological and Historical Record of the African-American Community in Wilmington, North Carolina, 1865-1950*, the book will be a boon for local African-American genealogy. The 614 page hard back chronicles the social life, churches, schools, community affairs, political affairs, military affairs and businesses of the community, as well as biographical sketches of local citizens. For the genealogist there are the names of servicemen, clergymen and church workers, businessmen, community workers, entertainers, school teachers and children, politicians and health care workers. Release of the publication is expected to take place on September 19. Mark you calendars to attend the special presentation which will take place at the library.

Looking for a long lost relative who went to Georgia? *Lowndes County, Georgia, Probate Recorded July Term 1847 -January Term 1852*, has recently been published by Charles R. Corbett. The volume contains a complete transcription and full name index to the original courthouse register in Valdosta, Georgia. Many families from Southeastern, North Carolina, who removed to that area prior to the Civil War, are listed. The author has graciously presented a copy to ONHGS and it can be viewed in the library.

Compugenics by Gerald McKenzie

This is the end of the second year of the Computer Special Interest Group. I can't believe how fast time has past and how the technology of genealogical computing has changed and expanded.

In our most recent meeting of April 14, we discussed the many new revisions and upgrades of genealogy programs that are being offered. In a straw poll of attendees I found many who have more than one genealogy program. Some like the printing features of one program while preferring the data input protocols used by another. This is a most acceptable practice, but one should never try to maintain two identical databases of individuals, events, and places. It is far more efficient and far less prone to error to keep all of one's data in one (and only one!) program and simply export the required data in GEDCOM format for import by the other program for printing. Once the printing is completed the imported data may be erased to prevent any mixups or confusion. I'll not dwell on the terms: "import", "export" and "GEDCOM" as they are well documented in the HELP function of any of the genealogy programs.

The above strategy works well for text, but is a bit more complicated for photographs or other imagery. Because of the way each of the genealogy programs handle the graphic materials, it will be necessary to import each of the desired images used by the main database individually into the story-book or portfolio of the secondary database for printing. After the printing has been completed, the deletion of the secondary database will eliminate the reference to the locations of the graphic images, but not the images themselves. However, Murphy's Law mandates that one should BACK UP DATA that would cause you agony if it were to disappear.

In the latest issues of *Everton's Genealogical Helper*, *Heritage Magazine* and *Genealogical Computing* (these are all excellent periodicals carried by most libraries ... usually in the local history room or genealogical section ... if not by yours, usually a request to carry them will suffice), there are several articles and commercial ads which describe the latest software and upgrades. Included are:

-Ultimate Family Tree which used to be called Family Gathering and has its "roots" in Roots IV and Roots V. Brand New!

-*The Master Genealogist* ... version 3.5.

-Family Origins ... version 6.0

-Family Tree Maker ... version 4.xx

The latest bargain in CD-ROM data is the recent release of "Super-Bundle" #2 by Family Tree Maker which bundles *WFT's* #8, #9, #10, 11, and #12 for \$59.95 ... previously each CD was selling for between \$30 and \$40 per disk. The latest CD of this World Family Tree series is #18. So, it is expected the another "Super Bundle" of *WFT's* 13-17 will be available in the near future.

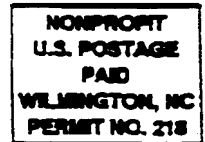
January, February & March dues will have no change.
