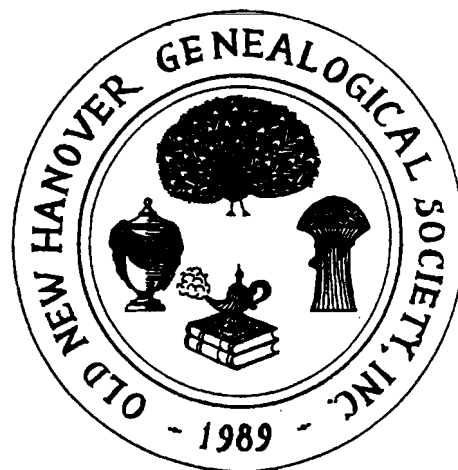

For Battalion; N.C.T. for North Carolina Troops; N.C.S.T. for North Carolina State Troops; N.C.H. Art. for North Carolina Heavy Artillery; N.C.L. Art. for North Carolina Light Artillery; and * indicates that the soldier was killed in action. The 10th Regiment included the 1st NC Artillery; the 36th NC Regiment included the 2nd NC Artillery; and the 40th Regiment included the 3rd Artillery.]

Last time I was complaining about the heat and also Bonnie came and went. Now the fall weather has come and is a welcome relief... not to mention the end of hurricane season.

As I mentioned before, the price of computers has continued to drop along with the price of peripherals. A 5.1 gigabyte hard-drive is available for \$179 with a \$30 rebate. I can remember paying \$220 for a 40 megabyte drive. The Internet continues to chug along in high gear and very high speed modems are making it very easy to access, download and transfer very large files. Sending a photo by **Email** (as an file attachment) is no longer a real test of one's patience. Even voice communication (via the Internet) has become rather common place. The *Old New Hanover Genealogical Society* will soon have its Web Site up and running. I don't know all of what will be included, but I do know it will contain a listing of all the **Email** addresses of members that have provided them to me. I have become enamored of a particular search engine which accesses several other search engines to do searches in parallel. It has options for times of searches of 7, 10, 15 and 30 seconds. I can't believe what it comes up with in 7 seconds. The address is www.infind.com, put it in your favorites folder.

Another bonus has been added to the Internet computer at the Local History Room of the NH County Library ... a new laser printer. This is directly connected to the computer and not shared through a network. What a great convenience it is to be able to directly print a article or photo from the web ... or from Dr. Fales photographic collection of early Wilmington.

The collection of CD's at the Local History Room continues to grow with the addition of two new CD's ... The Passenger & Immigration Lists and a new CD of Southern Genealogies. Soon to be added is the World Family Tree CD bundle #4 ... **WFT's 18,19,20,21, & 22**. We have probably the largest and best collection of CD's used for genealogical research within 200 miles of

Wilmington. I enjoy showing people how to use these databases on my volunteer days at the library. The size of these databases would occupy over 50,000 volumes of text. And, it occupies just one little corner of the local history room.

It has been my observation that there is very little new software coming available on the market. Of the few new offerings, voice recognition or voice activated software and image manipulation softwares seem to dominate. I have had little experience with either and not a warm feeling for voice activation (or dictation). Because I am a two fingered typist, this may change. As for the image manipulation software, which includes photo display, editing and cataloging ... my experience has been with a program called *ProOCR100*® ... an Optical Character Recognition software by *Visioneer*®. I was most pleased with this program in its ability to translate scanned images directly into **editable** text. The price of the program (about \$50) is much less than several of the price of other OCR programs.

In the arena of genealogical software there seems to be no end to the variety, upgrades and features being offered. All of the top flight programs include capabilities such as:

- Full blown word processors
- Photograph albums and on screen thumbnail photos
- Import** of audio (taped voice)
- Connectivity with the Internet
- And much more

The only limit seems to be the users ability to figure out how to use all of these "goodies". I personally have and use five different programs ... mainly for the variety of printing or listing options (or formats) offered by each. I keep my database in **ONLY ONE PROGRAM** and transfer the needed data as a GEDCOM file for printing or listing by another program as needed. Please do not try to maintain two databases containing identical individuals ... it won't work!



Marriage and Death Notices from the **Wilmington**, North
Carolina Tri-Weekly Commercial

[This is the conclusion of a series of marriage and death notices submitted by Helen Moore Sammons. These are dated in the **1850's** and can be viewed on microfilm in the Local History Room at New Hanover County Public Library]

Thurs 9 Jan 1851- Died: In New Hanover county on the 26th ult., at the residence of her son, Jeremiah Hand, Mrs. Ann HAND, wife of the late Jeremiah HAND, and the last daughter of the Hon. Timothy BLOODWORTH, aged 85 years and 3 months.

Sat 12 Dec 1857- Died: On the 2d December at his residence near South Washington, Dempsey HARRALL, Esq., aged 53 years and 6 months. He leaves a wife and eleven children.

Sat 18 Jan 1851- Died: On Sunday, 12th inst., Charles Betts, only son of the late Rev. Theophilus HUGGINS, aged 3 years.

Thur 19 June 1856- Died: In this town on Sunday, 15th inst., George Thomas, son of John R. and Catherine HUNT, aged 1 year, 3 months, and 17 days.

Tues 25 March 1851- Died: Recently, in Cumberland County, the body of Tilghman HUNT was found in Rockfish Creek, having been murdered by some person or persons unknown. He has no family and is about 40 years of age.

Tues 11 Mar 1856- Died: In Fayetteville on the 5th inst., Mrs. Harriet E. HUSKE, wife of Mr. Wright HUSKE and daughter of the late William W. HALL.

Thur 17 Apr 1851- Died: In this town on the 15th inst., Charles HUTCHINS, aged about 28 years.

Tues 3 June 1856- Died: In **Utica**, N. Y. on Wednesday, 28th ult., Mr. Isaac HUTCHINS, a resident of this town for several years, aged about 35 years.

Sat 7 Nov 1857- Married: In this town on the 4th inst., by Rev. C. F. Deems, Mr. Wm. HYSMITH to Miss Drucilla PARKER.

Thur 24 May 1855- Died: In Whiteville, Columbus county, N.C. on Friday, 18th May, 1855, Captain Stephen INNMAN, aged 40 years. He has left a widow and five small children.

Thur 17 Apr 1856- Married: In this town on the 15th inst., by Rev. S. M. Frost, Mr. William L. JACOBS and Mrs. Henrietta R. POPE, all of this place.

Tues 14 Oct 1851- Died: In Cincinnati, on the 22d September from congestion of the brain induced by cholera, Mrs. Elizabeth JAMES, wife of Israel E. JAMES, of Philadelphia, in the 56th year of her age.

Tues 7 July 1857- Died: On the 1st inst., George Leonace JAMES, infant son of J. S. and Martha J. JAMES, aged

1 year, 10 months, and 29 days. Burial in Oakdale Cemetery.

Thur 8 Nov 1855- Died: On Merrick's Creek, New Hanover county, on the 6th October, 1855, Hannah Ann Elizabeth, only daughter of Isaac and Hannah JAMES, aged 2 years, 10 months, and 6 days.

Sat 22 July 1854- Married: On the 22d ult., in Philadelphia, by Rev. John Dowling, D.D., Mr. Israel E. JAMES to Mrs. M. S. WALTER, eldest daughter of the late John STRUTHERS, Esq., all of that city.

Tues 11 Feb 1851- Died: At his residence in Holmes County, Miss. on Saturday, 19th ult., Mr. Joshua JAMES, in his 71st year. He was well known as a resident of Wilmington in former days and a member of the M.E. Church.

Tues 26 Aug 1851- Died: Lt. Thomas C. JAMES, of this place, was one of the prisoners executed on the 16th instant at Havana, Cuba.

Sat 13 Oct 1855- Died: In this town on Wednesday last, 10th inst., Mr. George JARMAN, aged 23 years. He was a member of the Fifth Street Methodist E. Church.

Tues 10 Jan 1854- Died: In this town on Wednesday last, Mr. John C. JARMAN, aged 23 years. He was a member of the M.E. Church.

Sat 21 Jan 1854- Died: In this town on the 8th inst., Mrs. Mary JARMAN, aged 64 years.

Sat 29 Apr 1854- Died: Departed this life on Thursday last, 27th inst., Mrs. Hannah JENNETT, aged 56 years, relict of the Rev. Jesse JENNETT. She had been a member of the M.E. Church for about 37 years.

Sat 3 Jan 1852- Died: In this town on the 31st ult., Rev. Jesse JENNETT, aged 84 years, 11 months, and 19 days. He had been in the ministry of the Methodist church about sixty years. He was an old inhabitant of this town and an estimable citizen in all the relations of life.

Thur 17 Mar 1853- Died: In this town on Tuesday, 15th inst., Mr. Jesse JENNETT, son of the late Rev. Jesse JENNETT, aged 54 years.

Thur 23 Feb 1854- Died: In Duplin county on the 5th ult., of smallpox, James H. JERMAN, Esq., in the 41st year of his age. He represented the county of Duplin in the Legislature twice and was twice elected Clerk of the County Court.

Tues 9 Aug 1853- Died: At Caintuck in this county, on Thursday last, 4th August, Daniel JOHNSON was shot and killed by Henry BARNHILL. The affair occurred on election day near the voting area, but was not connected with the election.

Tues 11 Mar 1856- Married: In Duplin county, N.C., on March 4th, 1856 by Rev. M. N. Taylor, Mr. Evan JOHNSON, of Bladen county, to Miss Alice H. WILSON.

Sat 23 Apr 1853- Died: Mr. James JOHNSON, along with John **FARRAR**, was drowned last Wednesday while in a small pilot boat which was overturned while tryng to reach the schooner, Sea Lion.

Tues 2 Sept 1856- Died: In **Fayetteville** on last Monday, 25th **inst.**, of bilious fever, Josiah JOHNSON, Esq., Editor of the North Carolinian. He was born at Feeding Hill, Mass. on 26th June, 1820. Burial was in Clinton, N. C., accompanied by the Lafayette Light Infantry of which he was a member.

Sat 14 June 1856- Died: In Bladen county on the 20th of May, Mrs. Mary JOHNSON, wife of J. JOHNSON, Esq., in the 62d year of her age.

Sat 21 June 1856- Died: In Greensboro, N. C. on Friday last, Peter JOHNSON was hanged for the murder of Yancey **Bartlet** DIAMOND, which occurred in Rockingham county during the Christmas holidays of 1853. (Greensboro Times- June 12)

Sat 16 Sept 1854- Married: In this town on Wednesday, 13th **inst.**, by Rev. A. P. **Repiton**, Mr. Thomas H. JOHNSON to Miss Julia F., daughter of Mr. John F. BISHOP.

Tues 6 Apr 1852- Died: On Tuesday, 23d of March, the body of Durrell JOHNSTON, a young man about 21 years of age, was found shot to death in Person county. At present it is not known if this was accidental death or murder.

Thur 25 Mar 1852- Died: On the 28th February, Ellen, daughter of James W. and Winefred JOHNSTON, aged 2 months.

Sat 19 May 1855- Married: On the 8th **inst.**, in **Chatham** county by Rev. A. W. Lineberry, William M. JOHNSTON, M. D., Associated Editor of the Spirit of the Aae, to Miss Mary E., daughter of William ALBRIGHT, Esq., of **Chatham**.

Thur 3 Aug 1854- Married: In Bladen county on the 26th **inst.**, by J. H. Clark, Esq., Mr. David JONES, of Columbus county to Mrs. Elizabeth **MASSAY**.

Sat 1 Nov 1856- Suicide: In the jail at Rutherfordton on Friday last, Dr. Edward R. JONES. He was undergoing a term of six months imprisonment for killing Andrew J. FAIN in Hendersonville some eighteen months ago.

Tues 5 June 1855- Died: In this town on the 2d **inst.**, Francis Oscar, son of William G. and Margaret Ann JONES, aged 4 years.

Thur 6 July 1854- Died: In this town on Sunday, 2d **inst.**, John C., son of Richard J. and A.E. JONES, aged 3 years and 5 months.

Tues 27 June 1854- Died: At Greenville, S.C. on Wednesday, 21st **inst.**, Col. John D. JONES, a citizen of this town, in the 64th year of his age.

Sat 27 **Dec** 1851- Married: At the Carolina Hotel in this place on Thursday, 25th **inst.**, by Rev. R. T. Heflin, Mr. Stephen B. JONES, of Clarke County, Georgia, and Mrs. Clarinda B. WYATT, of Richmond, Va.

Thur 6 Nov 1856- Died: In this town on the 3d **inst.**, Terese, youngest daughter of William B. JONES, deceased, aged 14 months and 9 days. Burial in **Oakdale** Cemetery.

Tues 28 **Dec** 1852- Died: **Goldsboro, Dec. 23-** Mr. William JONES, who was employed at the Steam Saw Mill at Waynesboro, was killed yesterday when the boiler exploded.

Sat 7 June 1856- Died: In this town on Thursday last, 5th **inst.**, William B. JONES, aged 39 years. He served his time as an apprentice with the present Editor of the Commercial. He leaves a wife and four children. Burial in **Oakdale** Cemetery.

Thur 23 July 1857- Died: A young gentleman by the name of Wm. F. JONES, of New Hanover county, N. C., died of consumption on Saturday, July **18th**, at the Rockbridge Alum Springs, Va. The body will be taken home by his friend, Mr. **Larkin**. (Petersbury Express)

Thur 20 Mar 1851- Married: In **Wilmington** on Tuesday, March **18th**, by Rev. T. Heflin, Mr. William G. JONES and Miss Margaret Ann PRICE.

Sat 22 Apr 1854- Married: In Duplin county on Thursday, 13th **inst.**, by George Smith, Esq., Mr. Zachariah JONES to Miss Barbara Ann SUMNER, all of Duplin.

Thur 5 May 1853- Died: Charles JORDAN, 22 years of age, a sailor belonging to the schooner, **Sea Lion**, fell from a boat and was drowned yesterday. He was from **Belmont**, Maine.

Sat 14 Feb 1857- Died: In the eastern part of this county on last Friday night, Mr. **Willis S. JONES**, aged 23 years, committed suicide by cutting his throat. (Hillsboro, Feb. 11)

Sat 15 Mar 1856- Died: W. G. KILKELLY, of Goldsborough, N. C., Agent for the Adams Express Company, was killed on Monday last in an accident on the Seaboard & Roanoke Railroad about sixteen miles from **Weldon**, N. C. He leaves a wife and four small children.

Thur 29 Nov 1855- Married: In this town at the Catholic Church on the 27th ult., by Rev. Thomas Murphy, Mr. John JUDGE, of New York, to Miss Mary F. FOX, of Charleston, S. C.

Thur 11 Feb 1858- Married: At Little River, S. C. on the 4th **inst.**, by Rev. T. G. Rogers, Captain F. JUSTICE, of **Wilmington**, N. C. to Miss Amanda F., eldest daughter of J. J. VEREEN, Esq.

Tues 17 July 1855- Married: On the 5th of June last at **Aix la Chapelle**, Germany, Mr. Simon B. KAHNWEILER, of this place, to Miss Alwine LEVI, of **Aix la Chapelle**.

Thur 27 Jan 1853- Died: In Philadelphia on the 22d **inst.**, Miss Rebecca KAHNWEILER, in the 19th year of her age. She was a resident of this place during last winter.

Tues 6 May 1856- Died: In this town on the 3d **inst.**, Agnes, infant daughter of J. L. and E. A. KEEN, aged 17 mos.

Thur 22 June 1854- Died: In this town on the 22d **inst.**, James S., infant son of James L. and E. A. KEEN.

Thur 15 May 1851- Died: In this town on the 13th **inst.**, Mrs. A. M. KEITH, wife of Mr. B. F. KEITH, aged 21 years.

Thur 31 July 1856- Married: In Bladen county on the 24th **inst.**, by Rev. Haynes Lennon, Mr. James M. KELLEHAN to Miss Isabella, daughter of Daniel CLARK, deceased.

Sat 4 Aug 1855- Married: On the 2d August, 1855 by W. N. Peden, Esq., Mr. James H. KELLY to Miss A. B. WHITLEDGE, all of this town.

Sat 16 Sept 1854- Died: In Washington, Georgia on Sunday, 3d **inst.**, Mr. John J. KELLY, in the 40th year of his age. He was a native of this State.

Sat 24 **Sept 1853**- Married: In this town on the 22d **inst.**, by Rev. James Jamieson, Mr. Oliver KELLY to Miss Anna E. WALKER, all of this place.

Sat 9 Sept 1854- Died: In Charleston, S. C. on the 6th **inst.**, Mr. Joseph KENDRICK, a native of Maine, for several years a resident of this place, but for the last three years a resident of Charleston.

Sat 6 Oct 1855- Married: In this town on Wednesday, 3d **inst.**, by Rev. A. Paul **Repiton**, Mr. William **KENION** to Miss Zilla C. **BARLOW**.

Sat 6 **Oct 1855**- Died: In Sampson county on September 27th, William Alexander, infant son of S. B. and Rebecca KILLETT.

NEW HANOVER COUNTY DEED BOOK "D"

[Many of New Hanover County's earliest records were destroyed by courthouse fires. What was left of the county's first two deed books, A and B, was combined to form book AB. This book was abstracted many years ago by Mae Blake Graves. Deed Book C was published in the *Courier* from 1993 to 1996. This series of abstracts from Deed Book D began in the Summer 1997 issue of the *Courier*. New Hanover was formed in 1729 from Craven County. Bladen and Onslow counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed to Sampson County in 1795, and Pender County, last but not least, broke away from New Hanover in 1875. The following abstract of Deed Book D, which covers many early records from the above counties, was compiled by Ida Brooks Kellam in 1939 and 1940.]

Page 153. September 20, 1754. Archibald **McLaine**, Planter of Rowan's Bluff in New Hanover County and Elizabeth his wife, otherwise Elizabeth Rowan, to Hon. Matthew Rowan, Esqr. "President and Commander in Chief in and over said Province of North Carolina." Said Matthew Rowan did on Feb. 8, 1741 convey to "Elizabeth Rowan, Junr. Daughter of the said Elizabeth now wife of said Matthew Rowan, by Jerome Rowan late of the County and Province aforesaid merchant, deceased," 176 acres joining Matthew Rowan. Said land sold by Archibald **McLaine** and wife Elizabeth to Matthew Rowan. Wit: Felix **O'Neill**, John **MacLaine**.

Page 155. Thomas Nunns of Liverpoole county of Lancaster, mariner, apptd. Edward Trafford, Joseph Davis, and Joseph Bird of same place, his attorneys to collect from Henry DeRossett of Cape Fear, N.C.

Page 156. John Cooper, Merchant of Charles Town appointed Mr. Benjamin Morrison of Cape Fear, N.C. his attorney, May 4, 1754. Wit: John **MacKenzie**, Alexander **MacAutey**.

Page 157. Dec. 10, 1752. John Rutherford, Esqr., of New Hanover County to John **Mott**

of same place 180 acres at mouth of Barren Inlet Creek on New Topsail Sound. Said land formerly seized by the State and valued by John Watson, Jonathan Watson and Joshua Grainger. Wit: Robert Schaw, Alexander Duncan.

Page 158. Dec. 13, 1754. Edward Reiley, Planter of New Hanover County to Algerton **Willis** of same place, 300 acres. Said tract given said Edward **Reiley** by will of William Reiley his father.

Page 159. Martin **Moreland** of North Shields in Northumberland County, England to Lewis DeRossett of Wilmington, N.C. a vessel called the "Owners Good Will" at anchor in Cape Fear River, N.C.. March 20, 1754. Wit: William Walker, Mary **Busall**.

Page 161. Patrick **Carryl** and John **Alsop** of New York, Executors. Of Thomas Moore, late of Wilmington, deceased appointed Daniel **Dunbibin** their attorney to collect for estate of said Thomas Moore. May 16, 1755. Wit: Nathaniel **Budwill**, Simon Payne.

Page 161. Adam Darling of Long Island appointed Daniel **Dunbibin** his attorney to collect from Joseph Blythe.

John Bevean of New Hanover County to Evan Jones a 1000 acre Plantation 16 miles above Rocky Point on East side of North East River, purchased from Maurice Moore the first patentee on Sept. 12, 1732, by said Bevean. Proved 1755.

Page 163. March 22, 1755. John James and his wife Margaret James to Alexander **Willson**, all of New Hanover County, 200 acres of land. Wit: Joseph **Bowen**, Caesar Hoskins, Robert **McRee**, John Cook and Jonathan Evans.

Page 163. Will of Philip Gaborell, mariner. Dated June 7, 1754. Proved Feb. 1756. All my worldly goods and Personal estate, after my decease, "to my Father Richard Quince, merchant of Cape Fear in Carolina. I leave in charge the Sloop Brunswick and cargo to Capt. Thomas Wright for my owner, Richard Quince." Wit: William Davis, Robert Coatness, James Allen.

Page 163. May 23, 1755. James Thomas to Thomas Ready, 120 acres in New Hanover joining Joseph Poitevint.

Page 165. Will of Joseph Poitevint of the Parish of St. James. Dated November 1, 1752. Proved February 1756. To wife Elizabeth Poitevint and son John Poitevint the whole of my estate. Exrs. Wife, Elizabeth, John Gibbs, James Poitevint, George Gibbs. Wit: John Taylor, Samuel Taylor, Ann Ottey.

Page 166. Will of James Rezan of Wilmington. Dated November 15, '1755. Proved February 1756. To wife Rachel Rezan all lands, 940 acres, and she to be sole Executrix.

Page 166. March 24, 1743. Archibald Hamilton, attorney at law, to Roger Moore, Esqr. a plantation of 1000 acres on Town Creek, on West side of Cape Fear River, beginning at a stake that divides the land from the land of Mr. John Moore, deceased, also 24 slaves.

Page 168. February 26, 1754. Honorable James **Hassell**, Esqr., to Fortune **Stanton**, 350 acres opposite Cabbage Inlet, land secured from Thomas Brown. "Fortune Brown now Fortune **Stanton**, the widow and devisor of the said Thomas Brown."

Page 168. Will of David Lindsay of Wilmington, "intending to visit England and Ireland, well assured of the uncertainty of life and considering the dangers of the sea." Dated November 12, 1754. Proved February 1756. 1. Plantation bought from Samuel Johnston named Nell Town, to be sold if necessary to pay debts. 2. To Rebecca Stevenson, daughter to Charles Stevenson of Charles Town, 50 lbs. 3. To friend Dr. Isaac **Faris**, 50 lbs. 4. To Miss Rebecca Dry, daughter of William Dry, esqr., 30 guineas to purchase toys, rings, etc., as her mother, Mrs. Mary Jane Dry may choose. 5. To brother Samuel Lindsay, of Newry, properties in Ireland, he to pay to sister Rose (wife of Joseph Leewright of Banbridge) 60 lbs. Executors: William Dry, Mr. Alexander **McCulloch** my Cousin Deputy Auditor of this Province and Brother Samuel Lindsay if he arrives in America. Wit: Thomas Nunns.



Page 169. Jan. 16, 1756. **Martin Holt** of Wilmington (son and heir of Martin Holt, late of the Town of Brunswick, deceased, to Francis Erwin of New Hanover County, 640 acres on New Topsail Sound including the Fork of Lee's Creek joining Thomas Connor and Archibald Nicholas.

Page 171. February 4, 1756. Martin Fryer, Planter of New Hanover County of Edgecombe County, 100 acres on Black River.

Page 172. Will of Michael Lowber, of Topsail Sound. April 18, 1755. Proved 1756. To wife Bridget all estate during her widowhood, then she to have 1/3rd, the other 2/3rds to be equally divided between my 4 sons and 2 daughters, namely Michael, Thomas, Peter, John and Unity and Bridget. Exrs. Wife and son Michael.

Page 173. Feb. 3, 1756. Joshua Grainger and Catherine his wife, to Mrs. Alice **Marsden**, a lot on the south side of Dock Street. Wit: Anthony Ward, Richard Player.

Page 174. April 8, 1755. Alexander **McKeithan** of Bladen County to Alexander **MacDougald** of Wilmington, merchant, a lot in Wilmrington. Wit: Richard Hellier and Joe Roe.

Page 175. December 22, 1755. William Walker, Esqr., High Sheriff of New Hanover to Cosmos Farquaharson, Doctor of Phisics, a lot on Princess and Front Streets formerly in the possession of Francis Davis, deceased. Wit: Thomas Turnbull, James Rutherford.

Page 177. January 16, 1756. Francis Erwin, planter of New Hanover County and his wife

Jane to John Sampson, Esqr. of Wilmington, a plantation, 320 acres, on Beaver Dam and Black River.

Page 178. Sept. 11, 1755. William Dry, Esqr. of New Hanover County "executor and heir of law to William Dry, late of Brunswick, merchant, deceased," to Caleb Grainger, Esqr., 200 acres on Northeast side of Smith's Creek.

Page 178. Sept. 12, 1755. William Dry to Caleb Grainger, 200 acres formerly owned by Robert **Halton**, deceased on N.E. side of Smiths Creek and bought by said **Halton** from Thomas Devane the original patentee. Robert **Halton** appointed Rebecca Dry, executrix and William Dry, Executor, who obtained judgement against John Rutherford and Matthew Rowan, Esqrs., administrators of estate of Robert **Halton** and thereby secured the land. Said Rebecca was dead, Aug. 6, 1752, when deed signed by Sheriff.

Page 180. Oct. 7, 1754. John Merrick, Gent. of New Hanover County to George Moore, Esqr. of Kendall, a lot (formerly bought from Robert Ellis, Jr., late of Philidelphia, merchant, through John Rutherford in Feb. 1752) containing in breadth 66 feet and in length from Front Street to Low Water mark, said lot joining one formerly belonging to estate of Robert Walker, Esqr. deceased and joining lot of Capt John **DuBoise**, said lot now "in occupation of Marmaduke Jones, Esqr.", attorney at law. Wit: Moses John **DeRossett**, John Davis, Jr., George Merrick.

Page 182. Oct. 6, 1754. John Merrick to George Moore of Kendall, a lot on Front Street.
